#### Aid Effectiveness and Management for Poverty Reduction

Mr. Pedersen has been extensively involved in the implementation of the principles of the Paris Declaration, including in the preparations for the Accra High-Level Forum in September 2008, and in the Millennium Development Goals focusing in particular on alignment and harmonization. In May 2008, Skadkaer Consult prepared a conference on Democratic Ownership in prepara-

tion for the Accra High-Level Forum, see <a href="www.democraticownership.org">www.democraticownership.org</a>. Mr. Pedersen has analysed the effects of the Paris Declaration in Fragile States and for Civil Society. He has closely followed the processes to develop Joint Assistance Strategies in African countries and has been responsible for a study comparing policies and procedures of donors in the Nordic+ group in order to identify possible barriers to Delegated Cooperation. He participated in the working group that designed Danida's Aid Management Guidelines, building on the harmonisation and alignment agenda. He was directly involved in the policy dialogues concerning the development of the first interim Poverty Reduction Strategy Papers (PRSPs) in Kenya and Malawi. Subsequently, he has been engaged in organising donor support to PRSPs and reviewing the progress of poverty reduction strategies in several of the Danish co-operation countries.

#### **Good Governance**

As a consultant, Mr. Pedersen has been assisting in formulating and reviewing Good Governance programmes in e.g. Indonesia, Bangladesh, Zambia, Mozambique, South Africa, Turkey and Yemen.

Until 2005, Mr. Pedersen was responsible for the quality assurance of Danish support to Good Governance and for knowledge-sharing in the Danish Ministry of Foreign Affairs and among Embassy-staff and advisors in the area of Good Governance. He has worked with Good Governance issues both at practical implementation level as well as appraising and reviewing support programmes in the field.

Good Governance issues were also in the forefront in donor support to Kenya and Malawi, when Mr. Pedersen served at the Danish Embassies in these countries from 1999 to 2002.

### Fragile Situations, Security, Conflict and Transformation

With Mr. Pedersen as Team Leader, Skadkaer Consult Aps in June 2008 presented a study to "Identify Good Practices of Development Assistance in Support of Building Counter-Terror Capacity in Developing Countries", at the International Peace Institute in New York.

In relation to an internationally supported project to secure the Lebanese border to Syria, Mr. Pedersen has undertaken several missions, most recently in April 2008. In 2007 he undertook an assignment for the Danish Ministry of Foreign Affairs, looking at development assistance to fragile states and the World Bank's role in this. He also advised on more efficient interventions in fragile and post-conflict states, and in early 2008 he finalised a study on the achievements of Danish assistance to Iraq.

When employed by the Ministry of Foreign Affairs, Mr. Pedersen was responsible for the Danish Africa Programme for Peace, which renders support to the development of conflict prevention capacity and an African peacekeeping capability involving AU, ECOWAS, IGAD and SADC together with a number of regional civil society and research organisations in Africa. He was also responsible for defining the initial Danish governance support to Iraq.

In the transition to democracy in South Africa from 1992 to 1995, Mr. Pedersen administered support to various democratic organisations, mainly a range of civil society organisations, initially through 'Interfund', a consortium of Northern NGOs and later through the office of the EU-Commission.

Mr. Pedersen started his career working for UNHCR in the early 1980ies providing assistance to refugees in Djibouti and Uganda.

He has maintained a keen interest in efforts to assist conflict affected societies and societies under rapid transformation and was recently responsible for defining and reviewing Danida's support to Southern Iraq, Northern Uganda and refugee hosting areas in Zambia.

#### **Civil Society Support and Management**

Recently, Mr. Pedersen has performed several reviews for MS, the Danish Association for International Cooperation, in Uganda, Zimbabwe and Tanzania, and for a number of donors of support to NGO-projects in Bangladesh. He has also been analysing the effects of the Paris Agenda on Civil-society in Kenya in 2007.

Mr. Pedersen participated in the recent update of the civil society strategy and the first official, comprehensive strategy for Danish support to NGOs. Also, guidelines for administering the Danish Government's support to NGOs were developed under the supervision of Mr. Pedersen, when he was heading the NGO-unit in the Ministry of Foreign Affairs from 1995 to September 1997.

Prior to this he was Secretary General of Ibis, a major Danish development NGO, and was instrumental in establishing frame contracts for the bigger Danish NGOs.

In 1993, Mr. Pedersen was elected Danish representative to the EU-Commission-NGO Development Liaison Committee.

# Selected Assignments

**Aid Effectiveness** and Management:

South Africa 2008: Framework for support to South Africa-based organisations providing assistance to the Region. Based on an evaluation of Danish regional assistance to Southern Africa, the Danish Embassy in Pretoria requested Skadkaer Consult to develop a more comprehensive framework for this support in line with the Paris Declaration Principles and the Accra Agenda for Action (AAA). October – November 2008.

**Nepal 2008: Management of TA.** The Ministry of Education in Nepal is moving into a SWAp for support to the education sector. The background is that much TA, whether in the form of long-term advisers, training courses, or short-term consultancies, is not being properly managed and Nepal is not receiving the full value of the TA. The Ministry therefore requested a 5 day training course to be provided by Danida's Fellowship Centre, which had again contracted Finn Skadkær Pedersen to provide a 5 day course in Nepal for senior management in Ministry. The course was conducted in the first week of September 2008.

Denmark 2008: Democratic Ownership – Enriching the Paris Declaration. (www.democraticownership.org). Skadkaer Consult was assigned with organising a conference for Alliance 2015 and the Danish Ministry of Foreign Affairs in preparation of the High-Level Forum in Accra in September 2008. May 2008.

World Bank 2008: The World Bank's Engagement in Fragile States – Issues and Recommendations. In relation to the negotiations concerning IDA-15 one of the three items prioritised by Deputy Presidents for discussion was the role of IDA in Fragile States. The Danish MFA requested Skadkaer Consult in cooperation with Julian Brett (COWI) to present a study on this issue. June 2007.

Nordic+ 2005-2006: Barriers to Delegated Co-operation. Mr. Pedersen was Deputy Team Leader in an assessment of policies and procedures of six members of the Nordic+ group (UK, Netherlands, Norway, Sweden, Denmark and Ireland) in order to identify barriers to delegated co-operation and donor-harmonisation in general. The assessment was commissioned by Norad. Duration: 6 months.

Ethiopia 2005: Analyses of the Perspectives for Danish Development Assistance to Ethiopia, Niger and Mali. Team Leader. The analyses were commissioned by the Danish Ministry of Foreign Affairs as part of the process to decide on an additional programme country. Besides being overall responsible for all three studies, Mr. Pedersen personally wrote and undertook the research on Ethiopia in September 2005. Duration: 2 months.
